The EU Corporate Sustainability Reporting Directive is Imminent

The Corporate Sustainability Reporting Directive was first proposed in April 2021.

This new EU legislation developed by the European Financial Reporting Advisory Group (EFRAG) will gradually be coming into play over the next few years. It expands upon, and will replace, the Non-Financial Reporting Directive (NFRD), which has been in force since 2018. Like the NFRD, the CSRD sets out environmental, social and governance (ESG) reporting requirements for companies.

Its aim is to significantly expand the scope of the NFRD, both in terms of who needs to report and what needs to be reported.
